The minutes of the January 21, 2016 closed meeting were reviewed. **Upon a motion by Mr. Henderson, seconded by Mr. Passantino, the minutes were approved.**

Upon a motion by Mr. Passantino to go into closed session, seconded by Mr. Henderson, approved unanimously

The meeting continued in closed session. The following issues were addressed and discussed:

New Business

It was discussed that the IACID will no longer employ staff. The Northeast Kansas Chamber of Commerce will contract with IACID that will in turn invoice IACID staffing needs and associated taxes and expenses, etc. employees of the CID will be paid by the NE Chamber and will enter in contract then reimburse 100 percent of all cash expenses coming out of our expenses. The contract will be renewable on an annual basis. **Mr. Dana moved to approve employees of the CID be paid by the NE Chamber and be reimbursed 100 percent for all cash expenses and entering a contract between the CID and NE Chamber to that effect. The motion was seconded by Dr. Joslyn and unanimously approved.**
